INDIA: socio-economic development, education, treatment of underprivileged people through support of several nongovernmental organizations (NGO's). This includes support to 3 schools (≥ more than 600 children), orphan support programs (~230 children), HIV treatment (~150 people incl. 25 children), disability, formation of women self-help groups with microfinancing, vocational skill-training (~100 youth), a clinic for women's reproductive health including camps to screen for cervical cancer

VIETNAM: Housing and education program. Construction of simple houses (at \$1,000 per house; approx. 105 have already been built since the inception of the program); provision of tuition scholarships (approx. 169 children) and 44 bicycles to needy children; construction of a bridge in a rural village to allow villagers easier access to the town and children easier access to school. All these programs are done in the rural area of Kien Giang, Vietnam.

KENYA: Orphan and school programs, education and awareness programs for deaf youth and adults. Sahaya International supports several orphan and school programs in Kenya run by local NGO's that take care of approx. 160 orphans and provide basic education to approx. 1200 from poor families, particularly those living in slums. Sahaya International also provides support to the Kenyan NGO "Sahaya Deaf Kenya" which runs programs to help educate and empower deaf youth and adults with information about health (especially sexual health and HIV), and to educate hearing service providers about issues that deaf people face and give them skills and tools to bridge the communication gap.
