VIETNAM: Housing and education program. Construction of simple houses for underprivileged families (approx 150 have already been built), provision of tuition scholarships (~ 200 children and youth), construction of 2 bridges in rural villages to allow villages easier access to the town and children easier access to school. All these programs are executed in the rural area of Kien Giang, Vietnam.
